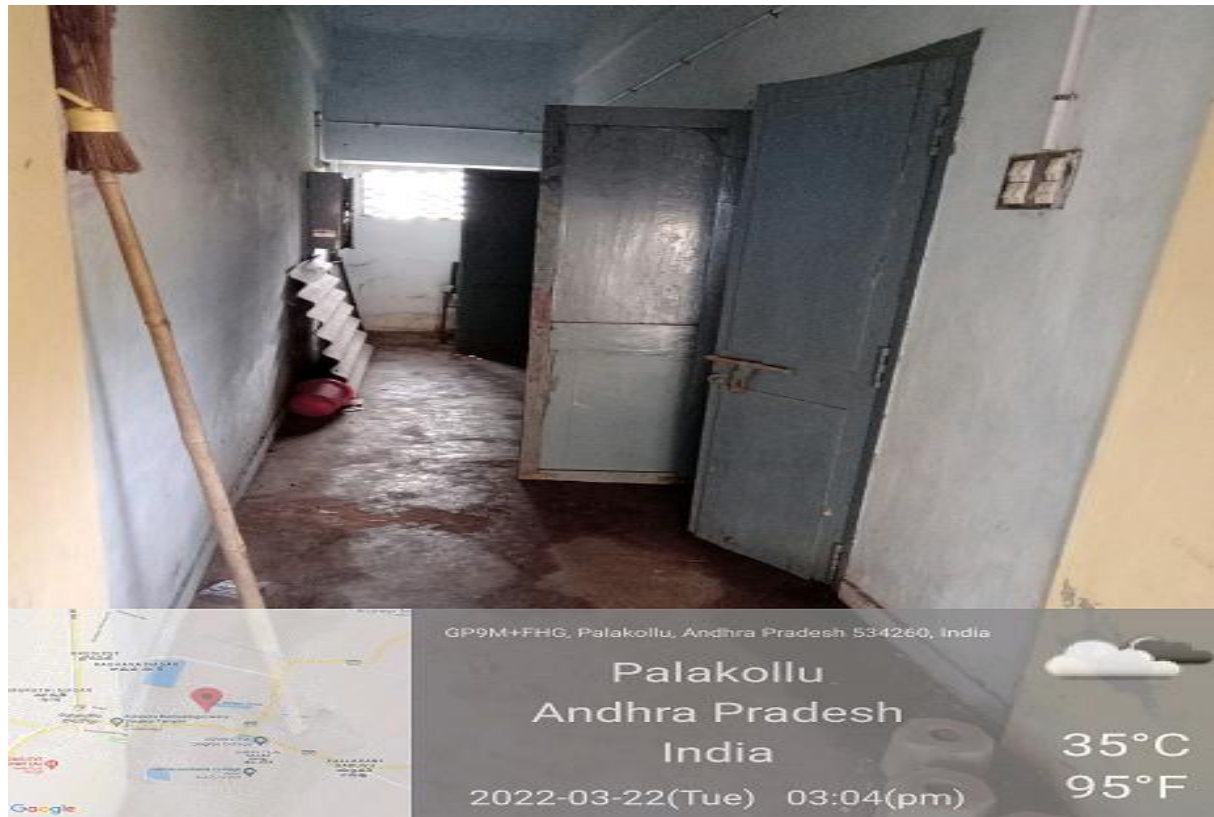

- The amount of the grant shall be drawn by the Account Officer, SERO, MCC, Hyderabad (Drawing and Disbursement Officer), University Grants Commission on the Grants-in-aid bill and shall be disbursed to and credited to the Principal, SRI DNR GOVT. DEGREE COLLEGE (W) PALAKOL 534260 by Electronic Mode through PFMS/ TSA at the following details:

- The college shall reimburse the amount to the Visually handicapped Teachers on receipt of actual bills as counter signed by the teacher for the purchase of books & recorded materials and on production of receipt from a Banker for the actual amount received by teacher for meeting for the period from April to March of the particular financial year for which the grant is being released.
- The grant should not be used for self-financing Aided teachers. In case the teacher is retires/retirement, the amount should be sent back immediately to the office so as to avoid penal interest.
- The College shall maintain proper accounts of the expenditure for the Grants, which shall be utilized only on approved items of expenditure.
- The assets acquired wholly or substantially out of University Grants Commission's Grant shall not be disposed, encumbered or utilized for the purposes other than those for which the Grant was given, without proper sanction from the University Grants Commission and should, at any time the College ceased to function, such assets must revert the University Grants Commission.
- The University/College/Institute shall maintain a Register of Assets acquired wholly or substantially out of the Grants in the prescribed form.
- The grantee institution shall ensure the utilization of grants as - and for which it is being sanctioned. In case of non utilization/part utilization, or mis-utilization of grants sanctioned by the Commission for the purpose for which the were approved and in accordance with the terms and conditions of the approval or does not furnish the required documents or is disaffiliated from the University the balance amount paid by the Commission shall be refunded by the College with simple interest @ 10% per annum on amount from time to time on withdrawal of balance from the date drawn to the date of refund as per provisions contained in General Financial Rules of Government of India will be charged.
